- 1) All Notices of Infractions must be received by the Court within 48 hours of issuance [IRLJ 2.2(d)].
- 2) All Traffic Citations shall be filed with the court within 48 hours of issuance [CrRLJ 2.16].
- 3) Defendants who receive a citation and are not booked shall be given an appearance date no later than 20 days from the date of issuance of the citation [CRLJ 2.1(b)(3)(iv)].
- 4) Defendants who receive a Notice of Infraction must respond, in person or in writing, within 15 calendar days of the issuance of the notice.
- 5) Infractions and citation must be written on separate forms and include the full statute or ordinance reference.
- 6) **Criminal offenses shall be cited as follows:**
 - Sheriff's Office: 8:30am Mon., Wed.
 - Vancouver Police Dept: 8:30am Tues., Thurs.
 - Washington State Patrol: 8:30am Wed., Fri.
 - Other state agencies: 8:30am Mon., Wed., Fri.**DV's shall be cited to 1:00pm the next judicial day***
DUI's shall be cited for 8:30am the third judicial day*
- 7) When citing a violation of the Washington Administrative Code (WAC), be certain that you also cite the R.C. W. that authorizes the establishment of the WAC provisions.
- 8) Any misdemeanor not listed in this schedule shall have a bail of \$500.00. Any gross misdemeanor not listed in this schedule shall have a bail of \$1,000.00.
- 9) It is extremely important that all citations be clearly written. Please include the defendant's telephone number on the citation or notice of infraction.
