The Clark County Parks, Recreation, and Open Space Plan (PROS) is the guiding document for the management of Clark County's parks, recreational facilities, open space, and trails. The County is considering adoption of this plan because the Greater Clark Parks Department was created in 2014 and the current parks master plan has expired. Adoption of the plan will make the county eligible to apply for grants from the state Recreation Conservation Office.


