**PUBLIC HEARING: SHORELINE MASTER PROGRAM – LIMITED AMENDMENT**

To consider a limited amendment to improve the consistency between the county's shoreline program and the state standards. The amendment would add text to clarify normal maintenance in the list of exemptions; regulate replacement of non-conforming residential structures that are damaged or destroyed; and clarify SMP text to improve implementation.

Oliver Orjiako, Community Planning Director, provided an overview. Gary Albrecht, Community Planning presented. Further discussion ensued. Don Benton, Environmental Services Director joined the discussion. Further discussion ensued about highlighting the changes. Further discussion ensued about rebuilding and replacement structures. Chris Cook, Prosecuting Attorney's office joined the discussion. Mielke inquired more about the County Code. Cook responded. Orjiako recommended for the item to be brought back in two weeks. Further discussion ensued about proposed changes regarding the state law.




