ALTERNATIVES CONSIDERED

Action Towing's facilities, as presented, do not meet the minimum specifications of the contract. Specifically, the indoor storage only has space for three evidentiary vehicles and the operator intends to have personal projects based in the same room. Additionally the outdoor storage, as presented, would have vehicles other than the evidentiary vehicles in the same fenced area. Having evidentiary vehicles in the same storage area is not acceptable and could result in the loss of criminal cases.

The Sheriff's Department intends to award this bid to the lowest responsive bidder.

SUBJECT: Award of Bid #2607 – Annual Sheriff’s Towing

This bid shall result in a two year annual requirements contract to provide towing and storage for the Clark County Sheriff’s Department.

Purchasing received three responses to Bid #2607. The bids were checked for accuracy, content, and compliance to specifications.

Upon review, it was found that the apparent low bidder, Action Towing of Vancouver, WA, did not meet the minimum bid specification requirements for indoor space, size and secure storage of evidence, and therefor was considered non-responsive and in accordance with Part 1, Invitations to Bid was rejected.

Purchasing and the Sheriff’s Department recommend that Bid #2607, be awarded to the lowest responsive bidder, TLC Towing of Ridgefield, WA, in the total bid amount of \$17,213.92, including Washington State Sales Tax and grant authority to the County Administrator to sign all bid related contracts.
