BACKGROUND

This project will reconstruct Sunset Falls Road from Dole Valley to Sunset Campground. The project will pulverize the degraded surface and add cement to stabilize the roadway base. The reconstructed road, once it has been graded to create a smooth driving surface, will receive a new layer of asphalt. The project also will include upgrading guardrails, signs and pavement striping.

For the safety of workers and the traveling public, Clark County will temporarily close portions of one travel lane to through traffic, reduce travel speeds, and limit truck traffic during construction.



IT IS HEREBY RESOLVED THAT **NE Sunset Falls Road Pavement Rehabilitation**

lying NE Dole Valley Road to Sunset Campground will be improved as follows:

Road Log No. 94000 from Milepoint 2.03 to Milepoint 7.50 will be improved as follows:

This project will reconstruct Sunset Falls Road from Dole Valley to Sunset Campground. The project will pulverize the degraded surface and add cement to stabilize the roadway base. The reconstructed road, once it has been graded to create a smooth driving surface, will receive a new layer of asphalt. The project also will include upgrading guardrails, signs and pavement striping.

For the safety of workers and the traveling public, Clark County will temporarily close one travel lane to through traffic, reduce travel speeds, and limit truck traffic during construction. Construction is planned June 2015 though November 2015.

The construction documents are complete and we are ready to advertise the contract for bids. The advertisement is contained in the attached Notice to Contractors.

NOTICE IS HEREBY GIVEN that sealed bids will be received until **1:50 P.M.** on **Tuesday, April 28, 2015**, by the Clark County Board of County Councilors through the General Services Purchasing Department, 1300 Franklin Street, Suite 650, Vancouver, Washington 98660, for the **Sunset Falls Road Pavement Rehabilitation, CRP No. 333312**; and other work; then publicly opened and read aloud at the Commissioners' Hearing Room, 6th Floor of the Public Service Center, 1300 Franklin Street, Vancouver, Washington 98660, at 2:00 P.M. on **Tuesday, April 28, 2015**, or as soon thereafter as the matter may be heard.

Description of work: Cement treated base stabilization and structural overlay, and upgrade existing substandard guardrail.

Primary bid items: Mobilization; Roadway Excavation (Incl. Haul); Crushed Surfacing Base Course; HMA Cl.; Beam Guardrail (Incl. Removing and resetting); Traffic Control.

Answers to bid questions will be posted on the project's "Bid Inquiry Log", also located on the County's Internet page, which will be updated twice daily, at noon and 6:00 PM. The questions and answers posted on the Bid Inquiry Log will not identify who asked the question, nor will that information be provided otherwise. It is considered exempt from Freedom of Information requirements. The last Bid Inquiry log update prior to bid opening will be 6:00 PM the day before the bid opening, and will display all questions and answers to the questions that have accumulated by the posting time. Questions asked after this time will not be addressed. Questions too late to be answered as of that posting will remain unanswered and will not be included in the log.

All bids shall be delivered to the attention of the Clark County Purchasing, P.O. Box 5000, Vancouver, Washington 98666-5000 or 1300 Franklin Street, Suite 650. Bids shall be placed in a sealed envelope, marked "Sealed Bid", which clearly states the name of the bidder, the project number, the project title, the date of the bid opening, and appropriate wording to indicate definitely the nature of the contents. Do not send bids by FAX or email. Bids submitted by FAX or email will not be accepted.

A bid proposal deposit, made in the form of a certified check, cashier's check, or surety bond in an amount equal to five percent (5%) of the amount of the bid proposal, shall accompany all bid proposals. Should the successful bidder fail to enter into such contract and furnish satisfactory performance bond within the time stated in the specifications, the bid proposal deposit shall be forfeited to the Clark County Road Fund.

The right is reserved by the Clark County Board of County Councilors to waive informalities in the bidding, accept a proposal of the lowest responsible bidder, reject any or all bids, republish the call for bids, revise or cancel the work, or require the work to be done in another way if the best interest of the Contracting Agency is served.




